**Communications Advisory Committee:** To promote the community and recognize the individuals who contribute to the identity of the community, and to impart information relevant to the community as a whole.

**Design Review Committee:** The mission for the DRC is to follow the Design Rules and the CC&R rules. The Rules provide an overall framework to allow the community to develop and progress in an orderly and cohesive manner. The Rules include minimum standards for the design, size, location, style, structure, materials, color, style of architecture, style of landscaping, and relevant criteria for the construction of improvements of any nature. They also establish a process for judicious review of owner-proposed new improvements and changes to existing improvements within the Community.

**Finance Advisory Committee:** The mission of the Finance Advisory Committee is to review records from the homeowners Association, golf operations, food and beverage operation, as well as reviewing records relative to the corporate investments for both operations and reserve aspects of our corporate financials. We are also charged with reviewing insurance renewal proposals and meeting with our investment counselor to be sure our investments meet the stated standard as outlined by the board of directors. The finance advisory committee has a subcommittee which has been created to work with our reserve consultants and maintenance department on a regular basis to be sure all items on our reserve analysis are appropriately listed and shown with appropriate dollar values and lifespan.

**Food and Beverage Committee:** To convene on a regular basis to assist the Board, the GM and F&B Management and make appropriate recommendations to the Board of Directors designed to improve the Food and Beverage experience in a manner that is beneficial to the Association and the community at large.

**Golf Advisory Committee:** The mission of the Golf Advisory Committee is to research and evaluate all golf related issues that come up in the community, reach a consensus, and recommend a course of action to the Board.

**Information Advisory Committee:** To convene on a regular basis to discuss the information needs of the community and to assist staff in the creation of news articles relevant to the SCSH community. These articles will be published on the SCSH website and in other forms of information delivery. The Information Committee will be responsible for advising the Board on new and better methods and technologies for information delivery as they become available on the market.

**Landscape Advisory Committee:** The mission of the Landscape Advisory Committee (LAC) is to advise the Sun City Shadow Hills Home Owners Association Board of Directors on how best to maintain and enhance the landscaping in the Common Areas of our community. Our mission is accomplished through regular inspections of the landscaping, evaluating homeowner concerns and suggestions and close communication with our landscape maintenance contractor and our community's management company.

**Safety Advisory Committee:** To convene on a regular basis to review security reports, evaluate incidents, liaison with Indio Police Department in areas of community safety and security, and make appropriate recommendations to the Board of Directors designed to improve safety and security at Sun City Shadow Hills.

**Facilities & Services Advisory Committee:** To provide consulting services to SCSH regarding Facility Maintenance and Facility Remodel Programs. Exclusions: Golf, Landscaping, and unless otherwise directed by the Board, the Committee is to inspect projects/contracts over \$50,000.00 to confirm they were complete per the agreement.
