

#### **WHY USE AN AED?**

- TO TREAT VENTRICULAR FIBRILLATION (VF), A
  COMMON CAUSE OF SUDDEN CARDIAC ARREST (SCA)
  +SCA OCCURS WHEN THE HEART UNEXPECTEDLY
  STOPS PUMPING
- PULSELESS VENTRICULAR TACHYCARDIAS (VTs)

### WHEN TO USE AN AED

VICTIM IS UNCONSCIOUS

ABSENCE OF NORMAL BREATHING

#### WHEN NOT TO USE AN AED


•WHEN A VICTIM IS CONSCIOUS

•WHEN A VICTIM IS BREATHING NORMALLY

#### LOOK FOR WALL MOUNTED AED SIGNS

#### **ABOVE THE AED CABINETS**

- CABINETS MUST BE UNLOCKED
- THE BUILDING'S
  LOCATION ADDRESS
  WILL BE ON THE WALL
  AND IN THE AED BAG



#### AED STORAGE TEMPERATURE

• 32 - 120 DEGREES FARENHEIT

## **COMMON QUESTIONS?**

- SAFE TO USE WITH PACEMAKERS DO NOT PLACE PADS ON TOP OF PACEMAKER/LOOK FOR SCARS OR A LUMP UNDER THE SKIN
- SAFE TO USE ON VICTIMS LYING ON WET SURFACES BUT DO NOT USE IN A SWIMMING POOL OR SPA
- SKIN MUST BE DRY USE VICTIM'S SHIRT, TOWELS, ETC. TO DRY THE SKIN
- AED IS SAFE TO USE NEAR CELLPHONES AND TWO-WAY RADIOS
- SAFE TO USE IF VICTIM IS WEARING AN OXYGEN MASK BUT DO NOT USE IN A PURE OXYGEN ENVIRONMENT

#### RESCUER DUTIES

- 1. STAY CALM AND EXERCISE TEAMWORK. QUICKLY ENLIST HELPERS!
- 2. PUT VICTIM ON THE FLOOR/GROUND.
- 3. SEND A RUNNER TO RETRIEVE AN AED.
- 4. DIRECT SOMEONE TO CALL 9-1-1 EMS KNOW THE ADDRESS.
- 5. DIRECT SPECTATORS AWAY AND THAT THEY BE QUIET. SILENCE THE BAND.
- 6. START CPR.
- 7. HAVE HELPER APPLY AED PADS WHILE PERFORMING CPR.
- 8. STOP CPR/ACTIVATE AED/KEEP VICTIM STILL/ALLOW NO ONE TO TOUCH VICTIM
- 9. FOLLOW AED VERBAL INSTRUCTIONS

- MONTECITO FITNESS CENTER (1): ADJACENT TO THE FRONT DESK AREA
- MONTECITO CLUBHOUSE (1): BEHIND THE LIFESTYLES DESK
- MONTECITO BALLROOM (1): PENDING LOCATION T.B.D.
- MONTECITO TENNIS COURTS (1): NEAR THE ICE MACHINE
- MONTECITO OUTDOOR POOL (1): <a href="PENDING">PENDING</a> / WILL BE NEAR THE RESTROOMS

- SANTA ROSA CLUBHOUSE (1): ADJACENT TO FRONT DESK AREA
- SANTA ROSA CLUBHOUSE (1): CURRENTLY BEHIND THE FRONT DESK MOVING TO THE BISTRO
